The Ministry of Trade, Indonesia has urged all stakeholders to support government policies regarding the management of palm oil, as it is an important commodity in global trade. The policies aim at providing flexibility to business actors, consumers and plantation managers by optimizing the supply of cooking oil as well as raw material at affordable prices.

Europe the biggest market for sustainable palm oil

A new report, 'Sustainable Palm Oil: Europe's business – fact, analysis and actions to leverage impact', jointly commissioned by the Roundtable on Sustainable Palm Oil (RSPO), European Palm Oil Alliance (EPOA), and IDH – the Sustainable Trade Initiative, presents an in-depth analysis of the current trends and developments in the European palm oil market and supply chain. The report also highlights that Europe is by far the largest consumer of sustainable palm oil in the world, accounting for 45 percent of the total global use of certified sustainable palm oil.

The State government has notified 26 districts for oil palm cultivation and has directed District Collectors to encourage farmers to take up cultivation on a large scale.

- India and Sustainability Standards (ISS 2022): The ninth edition of CRB's sustainable business Conference-ISS 2022 was held in a Hybrid format from 2nd to 4th November, 2022 in Delhi. The theme of this year's conference was 'Prioritising Nature and People in Business to Create Measurable Impacts'.
 - WWF Session at ISS: WWF-India organized a session on Exploring International
 Collaboration among G20 Members on Deforestation Free' Commodity Value Chains that
 focussed on examining ways to inform the G20 sherpa track on the subject and
 highlighted the possible roles for Governments and Industry of Producing Countries;
 Trading/Refining Countries and Buyers countries.
 - RSPO session at ISS: RSPO organized a session on Sustainable Palm Oil Dialogue (SPOD-India). The session highlighted the role of Indian Industries in integration of sustainability principles in the palm oil cultivation in India and the role of ecosystem actors (such as financial institutions) in supporting the transition toward uptake of sustainable palm oil.
 - Rainforest Alliance (RA) session at ISS: RA organized a session on Bridging the gap in access to finance for landscape interventions Key to address sustainability at scale. The session highlighted the current fiscal policies in India driving the landscape approach towards sustainability issues and examined the challenges of financial institutions in India to mobilize investment in sustainable landscapes.
 - CRB had set up an I-SPOC booth at the 9th edition of its Annual Sustainability
 Conference, ISS,2022. The booth showcased all the materials that I-SPOC Founders,
 Members have developed about and for the coalition.
